If a candidate did not respond by the deadline, "No response received" is printed. Candidates were asked to avoid references to their opponents. Photos are included for candidates who provided them.

#### **Wylie ISD Board of Trustees**

3-year term, elected district wide. Must be at least 18 years old, a United States citizen, a qualified voter, and a resident of the District. The Board of Trustees makes all final decisions regarding school district priorities, policies, personnel, textbooks, expenditures, and growth management. Trustees adopt a budget, levy taxes, and submit bond issues to finance construction projects.

**Vision:** WISD is on a path to being the best school district in the state. In 5 years, my hope is the district will be known for preparing students for life beyond high school and for achieving academic success for each student. We need to grow our CTE program by building partnerships within the community and expanding opportunities through a tradesman program. We work towards closing the achievement gap by attracting, hiring, and retaining the best teachers, offering

additional support to students in need of academic growth, and focusing on educating the whole child through the Wylie Way foundations.

**The whole child:** While academic growth plays a vital role in preparing students, WISD must focus on developing the whole student, as future success is dependent upon a holistic approach. We must continue to teach Wylie Way curriculum and promote building relationships, creating a plan and purpose, recognizing one's strengths and interests, and instilling core values. We must also promote and support a broad range of extracurricular activities, as students will learn skills such as leadership, collaboration, and perseverance. These behavioral skills will help students be better prepared for future endeavors.

**Finance**: School board trustees are entrusted with the stewardship of district resources and must ensure those resources are used effectively and efficiently for the good of all students. The school board needs to continue evaluating the needs of students and set and define clear, realistic, and attainable goals for student achievement. These goals and priorities will drive the budget process and the expenditure of funds. With state aid declining and the need for school finance reform, Wylie ISD must continue to budget conservatively, must operate transparently, and must prioritize effectively.

**Accessibility:** Wylie ISD school board trustees should seek to represent the needs and desires of the community and should engage parents, students, employees, and community members in important discussions regarding policy. Many methods should be used to facilitate communication to/from the school board – from inperson methods (developing relationships with parents and local organizations, focus groups and district committees, involvement in school and civic activities, open meetings) to technological methods (surveys, the district app, district/school websites, emails, videos, Superintendent's blog).

**Safety:** Student, faculty, and staff safety needs to be a top priority, and we need to continually examine, refine, and improve efforts to maintain safe schools. I am pleased WISD is working towards retrofitting all schools with buzz-in security systems, allowing schools a greater ability to monitor access. I am also pleased WISD is adding additional Student Resource Officers, as the presence of these officers greatly enhances security on our campuses. The importance of safety and security cannot be overstated, and WISD needs to continue to research additional safety measures.

**Other Issues:** One of the most important issues our district is facing and will continue to face is rapid growth. While growth presents a number of challenges, I believe our district should continue to focus on the needs of each individual student, should provide a safe environment for learning, and should promote inclusivity within an increasingly diverse community. We must be fiscally responsible with Wylie ISD tax dollars when evaluating building capacity and expansion. If elected, I will dedicate myself to helping our district navigate through the challenges and opportunities that lie ahead.

**Vision:** My vision for Wylie ISD in 5 years is a district that is enabling all students to be successful in the next stage of life, whether this includes career training, dual credit or advanced placement courses. A strong relationship with Collin College as they move into Wylie is vital for this vision. Parent education about these options will also be key. I also envision a district that is second to none in employee satisfaction. Morale amongs teachers is excellent now, but it can continue to improve by setting policies that enable teachers to play to their strengths within their own classroom.

**The whole child:** The Wylie Way is a great start. Character education for our students is key. Wylie ISD also generously supports the career and technical education departments in its high schools. This gives many students hands on experience with careers they might choose to pursue. In addition to these, a supported infrastructure of job shadowing and relationships with community businesses to expose students of all ages to real world working experiences would be invaluable.

**Finance**: With limited funds to work with, it is vital that the budget be examined closely. Making wise decisions about items purchased is important to ensure high return on investment for educational tools. The district must be always looking ahead and basing purchasing decisions based on objective information. Competitive

salaries for our faculty and staff should also be a priority. The strength of a district is the faculty, so it is vital that we attract and keep talented instructors.

**Accessibility:** The primary channel is the school board meetings themselves. Anyone interested is welcome to attend the meetings and address the board. Board member email contact information is also publicly available so that individuals can be reached if needed. Prompt response via email should be an expectation. The board should also publish meeting minutes to the public so that they can be reviewed.

**Safety:** I believe that creating an environment where students feel cared for and valued is the best measure for preventing violence. Restricting access to areas where students are located is also a good option. This can be achieved with badge access doors and/or single entry points to campuses. The current measures being taken to add video surveillance and buzzed entry to campuses is a great step in the right direction. To be clear, I feel that arming teachers is not a viable option. **Other Issues:** Safety will be an issue that continues to be at the forefront of the nation over the next few years. Another issue we face will be facilities to house our growing population of students. This will require a great deal of forethought and planning to make sure that money is spent responsibly in areas that will see the most growth to provide a learning environment that is safe and comfortable for all students.

**Vision:** My vision for our district is to be able to utilize Collin County College for our high school students. Upon their graduation, they should have an opportunity to receive, not only a diploma, but an associates degree. This is somewhat different

from our dual-credit program which currently allows them to receive college credit from courses. This will be integrated through a high school magnet program and will give them an advantage. Being able to pursue a post-secondary education earlier will surely set them up for success.

**The whole child:** I believe that when we discuss the whole child, we must consider the student and the students' family. We have a responsibility to our students and family to ensure that moral and ethical values are modeled before them. This will help them be successful in their academics. More importantly, this will help them be successful adults and leaders of tomorrow.

**Finance**: The current school finance system is in need of a overhaul. The tax-payers in Wylie carry a large burden while the state of Texas reapportions potentially useful assets. This issue of school finance is of great concern to our existing board and we must continue to lobby our state legislators, develop methods for reducing our current tax burden, and find ways to balance our approach to district finance.

**Accessibility:** The current channels that the school board uses are the most effective at this point. For those that have concerns that should be discussed with the board, I would encourage them to attend board meetings or give them a call. The information that is dissemenitated from the school board is successful in reaching parents across the district. They done a wonderful job!

**Safety:** The issue of school safety is a major concern across our nation. I don't believe that there is a single method that will totally eliminate the violence on our school campuses. We should consider three methods in our district. First, we must continue to limit the entry access points to our campuses. Second, we must increase the number of School Resource Officers (SROs) to ensure that the response time of the Wylie Police Department is as quick as possible. Finally, thoroughly trained and qualified school marshals across our campuses will be able to assist our SROs in times of danger.

**Other Issues:** I believe that, as our city and district continues to grow at a rapid pace, we must be proactive in management of the number of students on campuses. However, I know that our current school board is evaluating this situation. I also believe that, due to the diversity in our school district, we must look to expand the reach of our ESL program. We have many students that speak a primary language that is different from English. The concerns coming from our ESL advocates say that we must offer these students more assistance in developing their English Language skills.
