Questionnaires were sent to all candidates for each office, whether or not the race is contested. Candidate replies were subject to a character limit and are printed without editing or verification. If a candidate did not respond by the deadline, "No response received" is printed. Candidates were asked to avoid references to their opponents. Photos are included for candidates who provided them.

Parker City Council (3 seats)

2-year term, elected citywide. Must be at least 18 years old, a United States citizen, a qualified voter, and a resident of the city. The City Council establishes city policy through ordinances and resolutions.

Strategic: Being a part of Parker's city council for the past two years have really taught me the uniqueness, generosity, cohesiveness, and overall sense of community that Parker is known and loved for. Our city council is made up of individuals from varying backgrounds, life experiences, professional careers, and educational pedigrees, all of which contribute to allowing Parker to benefit from unique and often creative solutions to everyday issues affecting our residents and city operations. Parker is and has always been a "thriving community", and I hope it will always remain so, far into the future.

Economy: Parker has prided itself (rightly so) on being one of the few cities in Texas that is almost exclusively residential. This is by design, choice, and desire by the majority of Parker residents (including myself and my family) to preserve and protect Parker's "Uniquely Country" atmosphere and lifestyle. Our surrounding sister cities provide easy and quick access to a variety of businesses, restaurants, and entertainment venues. Parker's city council is not currently looking to attract additional businesses into the city, however we will continue to support existing businesses as needed.

Finance: Parker has maintained being one of the lowest tax rates and highest property value cities in Collin County. This is due to Parker's successful ability to operate all city operations on a limited but fiscally responsible city budget, despite its continuing growth and aging infrastructure. Since the primary source of city revenue is property taxes, we need to ensure that our city budget reflects sound and responsible financial decisions. If re-elected, I would work to ensure that fiscally responsible financial operations and low tax rates continue for the successful operations of Parker.

Diversity: As the first Asian American elected to Parker's City Council, I can attest to the fact that Parker is very welcoming of diversity especially in city government. Parker's previous city council was privileged to have the first African American ever to serve on the city council, and our city's various committees and boards have residents from various ethnic and religious backgrounds serving on them. Parker's growing population also reflects residents from a variety of diverse backgrounds, and Parker's city council will always encourage all residents to play an active role in their city.

Services: Parker has proven itself to be a responsive and effective provider of city services to its residents. During the February 2021 ice storm, in particular, Parker's city services including it's facility, emergency, utility, and city personnel ALL worked together to ensure that Parker's residents were safe and minimally impacted by the state's power outages. Going forward, Parker needs to ensure the city is adequately prepared for similar events, and are able to provide needed services for our residents without having to rely on county, state, or federal resources that may not arrive on time.

Pandemic: During the recent pandemic, Parker City Council worked to ensure that city operations and meetings were appropriately conducted in compliance with state and county mandated social distancing, hygiene, and mask requirements. City operations effectively continued, although at limited staffing capacity. Additionally, Parker City Council is aware of how pandemics and the subsequent economic fall out can adversely affect city operations in terms of budget, revenue, and staffing concerns. Balancing future pandemic concerns with the need to maintain essential city operations will be paramount.

Other issues: Currently, Parker City Council is actively working with residents to develop a much needed city hall, as the current city hall and police station are not adequately meeting the

needs of the city. Active community involvement with city council and city management is needed on this and other issues relevant to the city.

Finance: The City of Parker conducts a annual budget workshop followed by the establishment of the annual budget for the city. From this a budget is established for each department and presented for vote to the City Council. No change is needed to this process.

Diversity: The City of Parker has many committees and workshops where citizens are invited to participate. In addition to the public comments, at the beginning of each Council meeting citizen are encouraged to voice compliments and concerns. Citizens can also communicate directly with the Mayor, City Administrator and City Council as they choose.

Services: The only change will be in personnel as the city continues to grow. Increases in personnel are in concert with the established for that department.

Pandemic: All city workers including Police, Fire Department and city workers are sensitive to their and citizens safety during the pandemic.

Other issues: The city is in the process of providing accurate information to citizens for approval of a bond for the construction of a new city administration facilities. We are addressing this with public meeting and workshops to gain input and support for the project.
